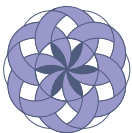

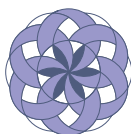

Your family's most important needs are addressed and reflected in the final legal agreements.

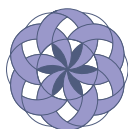
